

North Carolina Payment Details

Getting Started with your Friday Health Plan

1 Make your first payment

A. If you made your payment at the time you applied for your health insurance, you are all set.

B. If you didn't pay when you enrolled, make your payment by the 20th of the month for the following month.

2 How to make your first payment

A. You will receive an invoice in the mail and also by email. This will include your Member ID and amount due. You can pay by credit card, bank draft, or check. Here's how:


There you can find a copy of your ID card you can use to make doctor appointments and get prescription drugs until you receive your ID card in the mail. You can access this a few days after your first payment is processed.

4 Making Monthly Payments

Monthly payments (also called your "premium") must be made by the 20th of the month for the following month. If you do not make your payment, your insurance coverage will be terminated.

5 Setting up Automatic Payments

You can set up automatic payments in your Friday Member Portal or your Mobile App. Or you can call the Friday Care Crew and have them set it up for you. One less thing to worry about!



Home health coverage

If you are determined by a medical provider to need home healthcare, you can be appropriately monitored and treated at home, and covered for necessary medical equipment and medications for in-home treatment. This may include the following durable medical equipment and medications as deemed medically necessary by the treating provider: oxygen, any medications determined to be medically appropriate for the treatment of COVID-19, home infusion therapy, and electrocardiographs/cardiac monitors.



Prescription refills

Friday Health Plans will cover an additional one-time early refill of any necessary prescriptions to make sure you have medications in the event you need to limit contact with others.

If you are required to pay upfront at an out-of-network provider, you can submit a request for reimbursement by sending a copy of your receipt and itemized statement from the provider to questions@fridayhealthplans.com. National Access Program North Carolina

This program allows coverage of a Friday subscriber's dependents who attend school outside the Friday primary service area. They will be able to access local doctors and medical facilities as part of the Friday medical network. That means that they are covered to see a doctor outside of the state where your health plan was issued.

Who is Eligible for the National Access Program?

The National Access Program is only available to covered dependents of Friday subscribers who attend school and live outside of Friday Health Plans' primary service area.
